MEETING MINUTES Nº 02 OF THE PRESENTIAL BIDDING SESSION PROCESS No. 67103.230088/2023-18
PRESENTIAL AUCTION No. 003/CABE/2023

<u>Object</u>: Contracting of unaccompanied baggage transportation on behalf of three military officers, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

- 1. On the 25<sup>th</sup> of April 2023 at 12:00 pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Vanessa Erler Martins Lehmann Major together with the Support Team composed by Marcos Xavier da Silva Senior Master Sergeant and Patrícia Soares Lustosa Master Sergeant, designated by the Ordinance no 01, of 13<sup>th</sup> of January 2023, in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on DOU (Official Gazette of Brazil) no 63 on the 31<sup>st</sup> of March 2023.
- 1.1 After the result of Meeting no 01 was published the Auctioneer noticed a mistake in the decision that disqualified the company GALLEON for item 2 (London Rio de Janeiro).
- 1.2 In fact, the company GALLEON did not present the Annex IV. However, according to item 9.6 of the Bidding Process the Annex IV is optional, in case the bidder presents other documents of the company that prove the branch of its activity, like: Certificate of Registration/Incorporation, or Certificate of Incorporation of the company, or Articles of Association, or other organizational document similar, which is the case.
- 1.3 Therefore, the company GALLEON was qualified as it met the bidding requirements and presented the best proposal, ranking first for item 2.
- 1.4 Finally, the following companies were declared qualified, as they met the bidding requirements and presented the best proposals, ranking first in this Bidding Process, according to the table below:
