**MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION  
PROCESS No. ° 67103.240064/2024-40  
PRESENTIAL AUCTION No. 003/CABE/2024**

**Object:** Contracting of unaccompanied baggage transportation on behalf of eight military officers, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

1. On the 12th of June 2024 at 11:00 pm, at 16 Great James Street, London, WC 1N 3DP, the Auctioneer Vanessa Erler Martins Lehmann Major together with the Support Team composed by Marcos Xavier da Silva – Senior Master Sergeant and Patrícia Soares Lustosa – Senior Master Sergeant, designated by the Ordinance nº 09/ACI, of 09th of January 2023, and nº 38/ACI, of 03<sup>rd</sup> of April 2023, in order to carry out the procedures of the aforementioned Auction Session, in accordance with the Bidding Process and its respective annexes, published on DOU (Official Gazette of Brazil) nº 101, on the 27th of May 2024.

2. Initially, for accreditation purposes, the participating legal entity was identified, as well as their respective legal representative, according to the established in item 3. of the Bidding Process.

3. The Auctioneer asked the accredited to present the declaration of full compliance with the qualification requirements (Annex III and V).

As per item 3.1 and 3.2 of the Bidding Process the name of Mr. Robson Granero was not on the D&B report therefore the Auctioneer decided to open the qualification envelope to confirm if Mr. Robson Granero is the legal representative of the company, which was confirmed by the License issued by the Federal Maritime Commission (Washington, D.C.).

4. The following bidders submitted the documents prior to the public session:

- 4.2 MOBILITY UNBOUND LLC
- 4.3 GALLEON INTERNATIONAL SHIPPING COMPANY LIMITED
- 4.4. GERSON RELOCATION LIMITED

5. After the accreditation phase, the envelopes of Grupo Amygo, Mobility Unbound LLC, Galleon International Shipping Company Limited and Gerson Relocation Limited were opened and the price proposals were initialled by the auctioneer and support team.

5.1 Afterwards, the Auctioneer and the Support Team analysed the adequacy of the price proposal to the requirements of the Bidding Process. The following bidders were then qualified for the bidding phase:

The company GRUPO AMYGO presented incorrect calculations for item “c” (Total Insurance %). It was considered the right amount being US\$191.36 instead of US\$ 191.00. Therefore, the total amount for relocation is US\$ **18,495.36** instead of US\$ 18,495.00 as per item 8.5 of the Bidding Process.

The price proposal of the company MOBILITY UNBOUND LLC was sent in Portuguese, which did not meet the requirement established on item 5.1. Therefore, according to item 7.1 of the Bidding Process the price proposal was disqualified.

The company GRUPO AMYGO presented incorrect calculations for item “a” (Total Insurance %). It was considered the right amount being US\$ 802.88 instead of US\$ 802.00. Therefore, the total amount for relocation is US\$ **16,402.88** instead of US\$ 16,402.00, as per item 8.5 of the Bidding Process.

The price proposal of the company MOBILITY UNBOUND LLC was sent in Portuguese, which did not meet the requirement established on item 5.1. Therefore, according to item 7.1 of the Bidding Process the price proposal was disqualified.

The price proposal of the company MOBILITY UNBOUND LLC was sent in Portuguese, which did not meet the requirement established on item 5.1. Therefore, according to item 7.1 of the Bidding Process the price proposal was disqualified.

The company GRUPO AMYGO presented incorrect calculations for item “a” (Total Insurance %). It was considered the right amount being US\$ 168.48 instead of US\$ 168.00. Therefore, the total amount for relocation is US\$ **17,168.48** instead of US\$ 17,168.00, as per item 8.5 of the Bidding Process.

The price proposal of the company MOBILITY UNBOUND LLC was sent in Portuguese, which did not meet the requirement established on item 5.1. Therefore, according to item 7.1 of the Bidding Process the price proposal was disqualified.

The company GRUPO AMYGO presented incorrect calculations for item “a” (Total Insurance %). It was considered the right amount being US\$ 445.90 instead of US\$ 446.00. Therefore, the total amount for relocation is US\$ **15,853.90** instead of US\$ 15,854.00, as per item 8.5 of the Bidding Process.

The price proposal of the company MOBILITY UNBOUND LLC was sent in Portuguese, which did not meet the requirement established on item 5.1. Therefore, according to item 7.1 of the Bidding Process the price proposal was disqualified.

The company GRUPO AMYGO presented incorrect calculations for item “a” (Total Insurance %). It was considered the right amount being US\$ 160.16 instead of US\$ 160.00. Therefore, the total amount for relocation is US\$ **18,160.16** instead of US\$ 18,160.00, as per item 8.5 of the Bidding Process.

The price proposal of the company MOBILITY UNBOUND LLC was sent in Portuguese, which did not meet the requirement established on item 5.1. Therefore, according to item 7.1 of the Bidding Process the price proposal was disqualified.

The price proposal of the company MOBILITY UNBOUND LLC was sent in Portuguese, which did not meet the requirement established on item 5.1. Therefore, according to item 7.1 of the Bidding Process the price proposal was disqualified.

The company GRUPO AMYGO presented incorrect calculations for item “a” (Total Insurance %). It was considered the right amount being US\$ 413.40 instead of US\$ 413.00. Therefore, the total amount for relocation is US\$ **16,413.40** instead of US\$ 16,413.00, as per item 8.5 of the Bidding Process.

The price proposal of the company MOBILITY UNBOUND LLC was sent in Portuguese, which did not meet the requirement established on item 5.1. Therefore, according to item 7.1 of the Bidding Process the price proposal was disqualified.

6. The bidding proceeded, informing the present bidder (company MOBILITY UNBOUND LLC) about the disqualification. Therefore Mrs. Pauline Mary Collins left the public session at 12:34 pm.

7. The Auctioneer and Support Team carried on with analysis of all documents related to the qualification of the bidders whose proposals ranked first.

8. The companies GRUPO AMYGO, GALLEON INTERNATIONAL and GERSON RELOCATION LIMITED were considered QUALIFIED by meeting the qualification requirements.

9. Finally, the following company were declared qualified, as they met the bidding requirements and presented the best proposals, ranking first in this Bidding Process, according to the table below:
