MEETING MINUTES OF THE PRESENTIAL BIDDING SESSION PROCESS No. 67103. 240182/2024-58 COMPETITIVE BIDDING N° 007/BACE/2024

<u>Object</u>: SALE of the service vehicle, which is idle in the Defense, Naval and Aeronautical Attachment in Indonesia, in accordance with the conditions, quantities and requirements established in this Bidding Process and its attachments.

- 1. On the 14th of January 2025 at 11:00 am, at 16 Great James Street, London, WC 1N 3DP, BACE's Contracting Commission composed by Bruno Couto de Almeida Major, Elisangela Gonçalves Bastos de Alcantara Warrant Officer and Everton da Silva Loureiro Senior Master Sergeant, designated by the Ordinance n° 01/ACI, of 13th of January 2025, in order to carry out the procedures of the aforementioned Public Session, in accordance with the Bidding Process and its respective annexes, published on DOU (Official Gazette of Brazil) n° 238, on the 11th of December 2024.
- 1.1 There was no presence of any company.
