HIGHER AUTHORITY APPEAL ANALYSIS

OBJECTIVE

Analysis of the judgment performed by the Bidding Commission on the meeting minutes 024/CPL/2019 regarding the appeals and counter-arguments presented by AEROMOT - SEA AEOSPACE, IAI - ISRAEL AEROSPACE INDUSTRIES LTD and SAB - MILLENIUM TECHNOLOGIES on the judgment of the PRICE PROPOSAL of the Bidding n. 190102/CABW/2019.

ANALYSIS

As a result of the announcement of the PRICE PROPSAL made by the Bidding Commission, the bidders AEROMOT - SEA AEOSPACE, IAI - ISRAEL AEROSPACE INDUSTRIES LTD and SAB - MILLENIUM TECHNOLOGIES presented appeals and counter-arguments in accordance with item 33.1.1 and 33.2 of the IFB, respectively.

Therefore, in accordance with item 33.3.1 of the Invitation For Bid, since the Bidding Commission accepted some appeals and rejected others appeals to the price proposal of AEROMOT - SEA AEOSPACE, IAI - ISRAEL AEROSPACE INDUSTRIES LTD and SAB - MILLENIUM TECHNOLOGIES, the matter escalated to this Bidding Commission's Higher Authority.

CONCLUSION
