REPUBLISHING INVITATION FOR BID No. 230150/CABW/2023 MEETING MINUTES No. 004/CPL/2023

At 10:00 a.m. (EST) on May 5th, 2023, the Brazilian Aeronautical Commission's (BACW) Bidding Commission held a meeting for the Republishing of the Invitation for Bid No. 230150/CABW/2023, to be awarded based on the **LOWEST UNIT PRICE**, for the contracting of a specialized company for the services of relocation of UNACCOMPANIED BAGGAGE hereafter referred as Household Effects (HHE), door-to-door specialized moving company, which operates by sea, for the MILITARY PERSONEL of the Brazilian Aeronautical Commission in Washington DC, when returning to Brazil, at the end of their missions outside their homeland, as per the USER'S INFORMATION, Annex A of the Basic Project.

As registered in the Meeting Minutes No. 003/CPL/2023, from April 10th, 2023, in accordance with the Brazilian Law 8.666 from 1993, since the minimum requirement of 3 (three) valid proposals was not met for the first publishing of this Bidding, the Bidding Commission, with the approval of BACW's Chief, announced the republication for today's date.

The Invitation for Bid has been published at the Brazilian Gazette (DOU), Brazilian Air Force, BACW's and BACE's websites. For instance, on the BACW's website, the publishing of this Bidding Process has been visualized 98 (ninety-eight) times at the time of this meeting. The Bidding Commission has received the documents of 4 (four) companies: ALLIED INTERNATIONAL N.A, CONFIANCA LOGISTICS LLC, EXACT MOVERS AND SO EXPRESS.

The qualification documents sent by the abovementioned bidders have been verified and carefully analyzed by the Bidding Commission, and, based on that the companies **EXACT MOVERS** and **S.O. EXPRESS INTERNATIONAL, INC.** have been <u>QUALIFIED</u> in accordance with all of the requirements of this Bidding Announcement.

The Company **ALLIED INTERNATIONAL N.A** presented the Certificate of Liability Insurance, item 6.2.5, with the name of the Company SIRVA WORLDWIDE RELOCATION and the Recommendation Letters, item 6.3.2 of the Public Notice, with the name of the Company CONCEPT MOBILITY SERVIÇOS DE MOBILIDADE LTDA, SIRVA RELOCATION. In both cases, the Bidding Commission didn't identify the relation between the companies mentioned and the bidder ALLIED INTERNATIONAL N.A. All the documents must be presented with the name and Identification Number of the bidder.

The Company **CONFIANCA LOGISTICS LLC** did not deliver the Declaration from its Chief of Financial Officer (CFO), as determined on item 6.3.3 of the Public Notice.

As described on item 8.7 of the Public Notice, <u>it will be granted the deadline of 2 (two)</u> <u>business days, for the bidders to present any appeals</u>. The appeal must be presented no later than May 9th, 2023. After that a new meeting for opening the PRICE PROPOSAL will be announced by email and BACW's website.

At this point, having complied with all due legal and administrative procedures, the members of the Bidding Commission close this meeting, from which these minutes are derived, for signature



by all meeting participants and further incorporation into the Bidding file ("PAG") No. 67102.230150/2023-73.
