## REERVSE AUCTION N° 240038CABW/2024 MEETING MINUTES 05/2024

At 10:00 a.m. (EST), on March 21st, 2024, the Brazilian Aeronautical Commission's (BACW) Bidding Commission held a meeting for the Reverse Auction no 240038/CABW/2024, to be awarded based on the **LOWEST PRICE PER ITEM** for the contracting of unaccompanied baggage transportation on behalf of 04 (four) military personnel, in accordance with the conditions, quantities and requirements established in the Public Notice and its annexes.

The Bidding Process has been published on the Brazilian Air Force's, BACW's and BACE's websites, and on the Brazilian Official Gazette (DOU). For instance, on BACW's website the publishing of this bidding process had been visualized around 300 (three hundred) times previously to the time of this meeting.

Furthermore, the companies ALLIED INTERNATIONAL N.A. (Allied), SO EXPRESS MOVING INTERNATIONAL INC. (SO) an CONFIANÇA LOGISTICS LLC (Confiança) send brought the envelopes by email, but ALLIED INTERNATIONAL and SO EXPRESS send representants in person as well.

The company Allied had Ms. Suzanne Paton Weiner accredited to represent the company at the session, while the company SO had Mr. Sergio Souza de Oliveira accredited to represent it.

After accreditation, the Contracting Officer began the bidding phase and Allied won items 1 and 4 for US\$ 13,700.00 and US\$ 12,480.00, respectively; while SO had the best proposal for items 2 and 3 for US\$ 9,800 and US\$ 12,300.00, respectively.

Accordingly, the Contracting Officer requested that the companies Allied and SO send their adjusted proposals, within 24 hours, to the email chf.dlc.cabw@fab.mil.br or deliver them to the address 1701, 22nd St, NW, Washington DC 20008.

And, after signing these minutes, he suspended the session to send the adjusted proposals and analyze them.

After this, the Contracting Officer will set a new date for the continuation of the Session, disclosure of the analysis of the proposals, opening of the qualification documents and judgment of the qualification.

Having complied with all due legal and administrative procedures, the Contracting Officer closes this first stage of the meeting, from which these minutes are derived, for signature by all meeting participants and subsequent incorporation into the Bidding Process ("PAG") No. 67103. 240038/2024-21.
