At 10:00 a.m. (EST), on April 2nd, 2024, the Brazilian Aeronautical Commission's (BACW) Bidding Commission resumed the meeting for the Reverse Auction nº 240038/CABW/2024, to be awarded based on the LOWEST PRICE PER ITEM for the contracting of unaccompanied baggage transportation on behalf of 04 (four) military personnel, in accordance with the conditions, quantities and requirements established in the Public Notice and its annexes.

The Contracting Officer received the adjusted proposals within estimated time from the companies ALLIED INTERNATIONAL and SO EXPRESS.

Although all the bidding companies involved in this bidding were invited to the meeting – ALLIED INTERNATIONAL, SO EXPRESS and CONFIANÇA LOGISTICS LLC – none of them attended the meeting, and therefore, there was no indication of intention to file an appeal.

The qualification documents sent by the abovementioned bidders have been verified and carefully analyzed by the Bidding Commission, and, based on that, both companies have been QUALIFIED in accordance with all of the requirements of this Bidding Announcement.

Having complied with all due legal and administrative procedures, the Contracting Officer declared the company Allied International WINNER of the items 1 and 4, and SO Express the WINNER of items 2 and 3. Having complied with all due legal and administrative procedures, the Contracting Officer closes this Bidding Process, from which these minutes are derived, for signature by all meeting participants and subsequent incorporation into the Bidding Process ("PAG") No. 67103. 240038/2024-21.
