INVITATION FOR BID N° 240050-A/CABW/2024 MEETING MINUTES 03/240050-A/CABW/2024

At 10:00 a.m. (EST), on July 26th, 2024, the Brazilian Aeronautical Commission's (BACW) Bidding Commission resumed a meeting for the Bidding Process No. 240050-A/CABW/2024, to be awarded based on the **LOWEST GLOBAL PRICE** to contract a company to supply a set of landing gear for the Airbus A330-200 aircraft, as established in the Term of Reference 01/PAMAGL-TTEC/2024.

The Contracting Officer sent the Letter no 44/LIC/1838 so that the PAMAGL technical team could present an opinion on the acceptability of the technical documentation presented by AJW in the light of the requirements contained in Item 8.3 of the Terms of Reference.

Additional due diligence was carried out and the Company sent a Technical Capacity Certificate from Air Tank, as well as certificates from the FAA, EASA and CAAUK.

In addition, PAMAGL forwarded Technical Opinion 4/6077/2024, stating that the documentation submitted meets the requirements of Item 8.3 of the Terms of Reference.

In fact, AJW submitted sufficient documentation regarding its technical qualifications because, although it did not submit a specific certificate for the supply of a landgear set, it demonstrated that it had extensive experience in supporting VIVA's fleet of 737-300 and A320 aircraft, the fleet of FB Líneas Aéreas and AirTanker.

In addition, the company's website verified that the company has a certificate from the Nepal Authority, Singapore, a registration document in Canada and authorization from China.

Therefore, by means of all the documentation presented, in addition to that relating to economic-financial and legal qualifications, this Contracting Officer qualifies the company AJW and declare its winner of Reverse Auction.

This Contracting Officer asks that the bidding companies be informed and informs them that once they have been informed, they will have three working days in which to lodge an appeal.

And, after signing these minutes, Having complied with all due legal and administrative procedures, the Contracting Officer closes this Reverse Auction, from which these minutes are derived, for signature by all meeting participants and subsequent incorporation into Bidding Process ("PAG") No. 67102.240050/2024-36.
