MEETING MINUTES 01/240270/CABW/2024**

Due to the impossibility of accessing the email to check any bids that had been sent, the Contracting Officer started the session around 20 minutes late. At 8:50 a.m. (EST), on July 25th, 2024, the Brazilian Aeronautical Commission's (BACW) Bidding Commission held a meeting for the Reverse Auction nº 240270/CABW/2024, to be awarded based on the **LOWEST PRICE PER ITEM** for the contracting of unaccompanied baggage transportation on behalf of 15 (fifteen) military personnel, in accordance with the conditions, quantities and requirements established in the Public Notice and its annexes.

The Bidding Process has been published on the Brazilian Air Force's, BACW's and BACE's websites, and on the Brazilian Official Gazette (DOU). For instance, on BACW's website the publishing of this bidding process had been visualized around 182 (one hundred and eighty-two) times previously to the time of this meeting.

Furthermore, the companies ALLIED INTERNATIONAL N.A. (Allied), S.O EXPRESS MOVING INTERNATIONAL INC. (SO) and MOBILITY UNBOUND LLC (Mobility) sent the envelopes by e-mail, and the representants in person to attend the Bidding.

Mr. Sergio Souza de Oliveira was accredited to represent SO, Mr. Marcelo Camara Fonsi was accredited to represent Allied, and Mr. Robson Granero was accredited to represent Mobility.

The bidding phase was completed and the best-qualified bids were from Allied and SO Express, according to the Comparative Map. The Contracting Officer asked these companies to submit their adjusted bids within 48 hours.

Having complied with all due legal and administrative procedures, the Contracting Officer closes this stage of the meeting, from which these minutes are derived, for signature by all meeting participants and subsequent incorporation into the Bidding Process ("PAG") No. 67102.240270/2024-60.
