**REVERSE AUCTION Nº 240582/CABW/2024
MEETING MINUTES 01/240582/CABW/2024**

At 09:00 a.m. (EST), on December 12th, 2024, the Brazilian Aeronautical Commission's (BACW) Bidding Commission held a meeting for the Reverse Auction n. 240582/CABW/2024, to be awarded based on the **HIGHEST DISCOUNT PER ITEM** to supply aviation kerosene fuel, on demand, to supply aircraft and equipment of the Aeronautical Command on missions outside Brazilian territory, in accordance with the conditions, quantities and requirements of Term of Reference 01/SSCB/2024.

The Bidding Process has been published on the Brazilian Air Force's, BACW's and BACE's websites, and on the Brazilian Official Gazette (DOU). For instance, on BACW's website the publishing of this bidding process had been visualized around 447 (four hundred and forty-seven) times previously to the time of this meeting.

Furthermore, the companies Associated Energy Group LLC (AEG), AVIASUR CORP and JETEX forwarded the envelopes electronically to participate in this Bidding Process.

The companies sent their envelopes through their representatives AVFUEL, WORDFUEL and EXFIS.

The following companies registered representatives for the bidding phase: AEG, Mr. Stephen T. Leonard; EXFIS, Mr. Christopher Hambrock; AVIASUR, Mr. Jaime Villena; AVFUEL, Mr. George G. Guirgis and WORLD FUEL, Mr. John Bryan Wynn.

The bidding phase began and the winners are listed in the attached spreadsheet.

At the end of the bidding phase, the Contracting Officer tried to negotiate prices and then asked everyone to send their bids, adjusted to the latest bids, via biddings.cabw@fab.mil.br within 24 hours. After this, the auctioneer interrupted the session and informed everyone that the bids, as well as the qualification documents, would be evaluated by the Requesting OM and the Contracting Officer.

The Contracting Officer suspended the session and will inform you of the result of the analysis of the bids and documents via email.

Having complied with all due legal and administrative procedures, the Contracting Officer closes this first part of this stage of the meeting, from which these minutes are derived, for signature by all meeting participants and subsequent incorporation into Bidding Process ("PAG") No. 67102.2405822024-73.


